Research Institute for Electronic Science, Hokkaido University 2021 Research Students -Application Guidelines-

Providing that there are no obstacles barring admission, applicants that have passed the Research Institute for Electronic Science Council's screening shall be admitted as research students to work on specific topics of research.

1. Eligibility Requirements

- (1) Applicants must have completed an undergraduate program.
 Or
- (2) Applicants that are recognized as having equal or greater academic achievements as persons in category (1) above.

2. Admission Period · Research Period

- (1) Admission Periods: April or October 2021 (However, this shall not apply under special circumstances)
- (2) Research Period: 1 year (if there are special circumstances a term less than 1 year is possible)
 - * Extension for continuing research can be approved after completing the proper procedure. If the continuing research is under the same research title, tuition is charged but screening and admission fees are not charged.
